The ornamental design for a portable fluid dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a portable fluid dispenser showing my new design;  
 FIG. 2 is a rear perspective view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a side elevational view, as viewed from the left in FIG. 1;  
 FIG. 7 is a side elevational view thereof, as viewed from the right in FIG. 1; and  
 FIG. 8 is a bottom plan view thereof.  
 The broken lines shown in FIG. 1 of a water container are for illustrative purposes only and form no part of the claimed design.

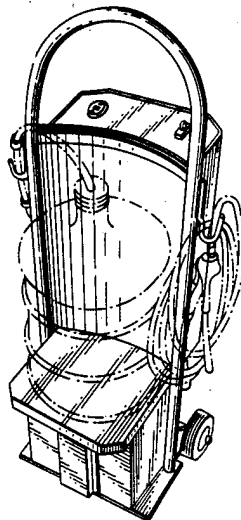

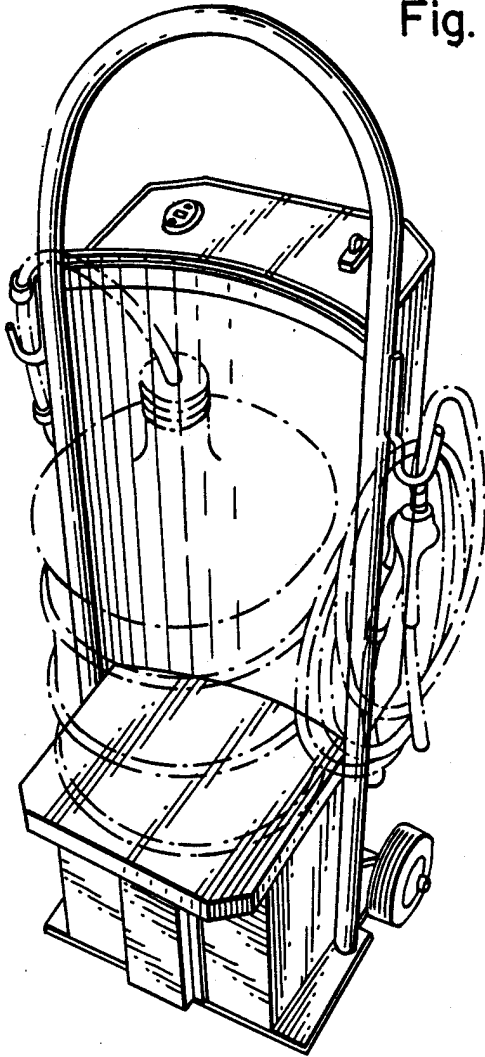

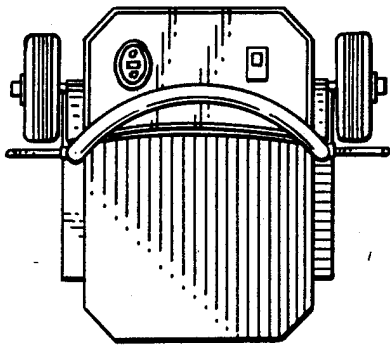
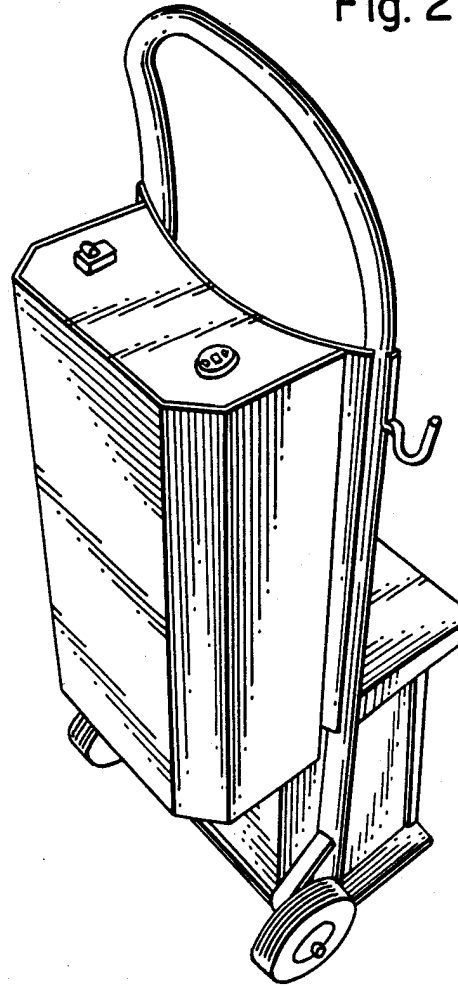

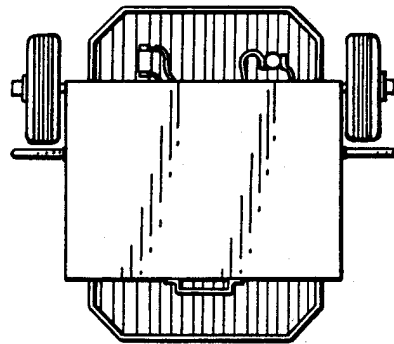

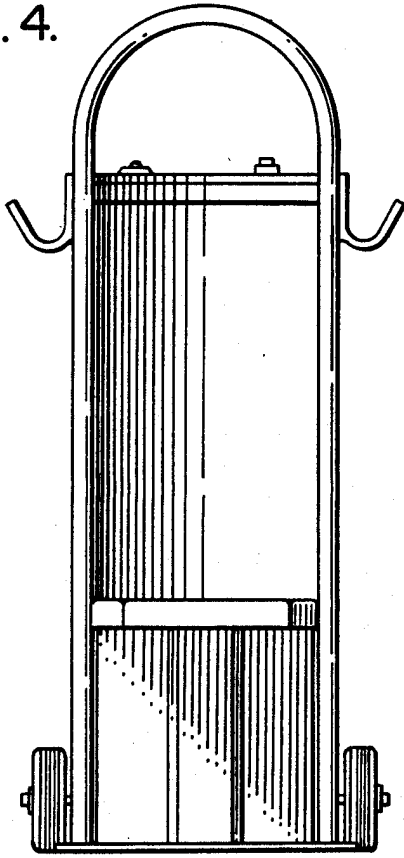

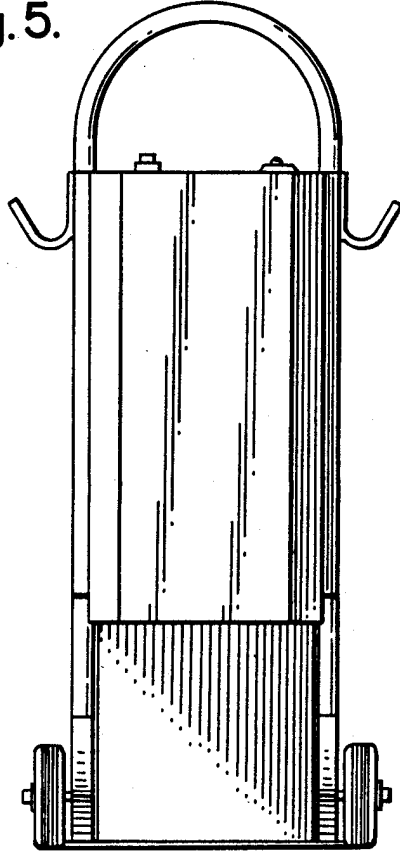

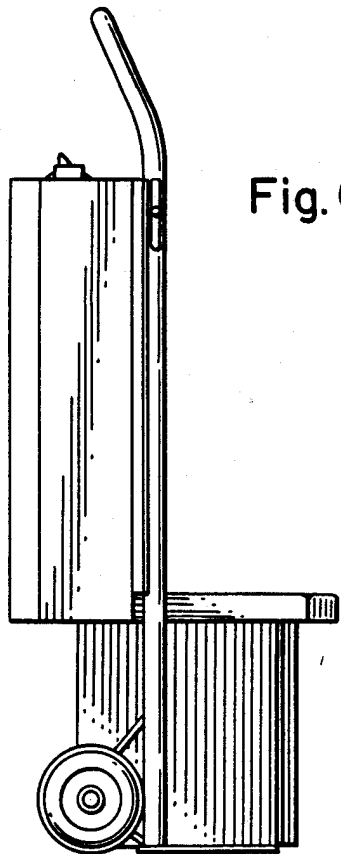
