**DESCRIPTION**

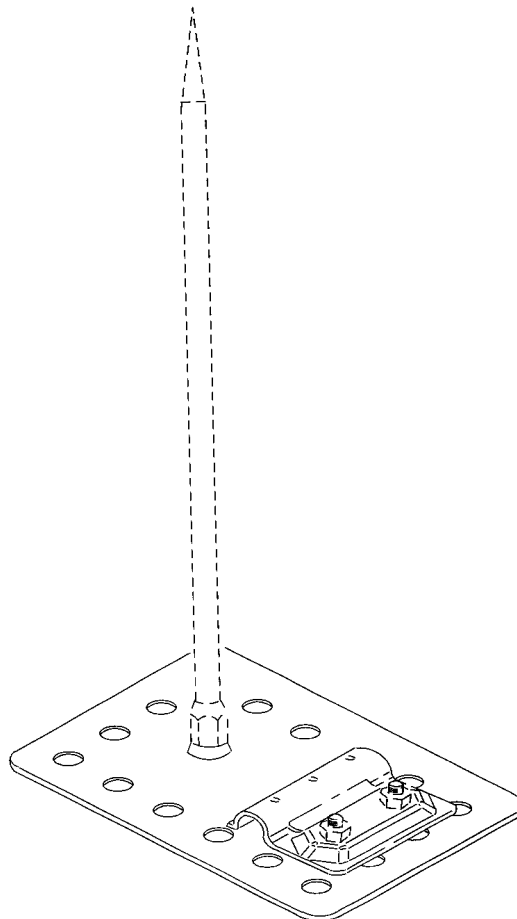
FIG. 1 is a perspective view of a lightning rod assembly showing my new design;

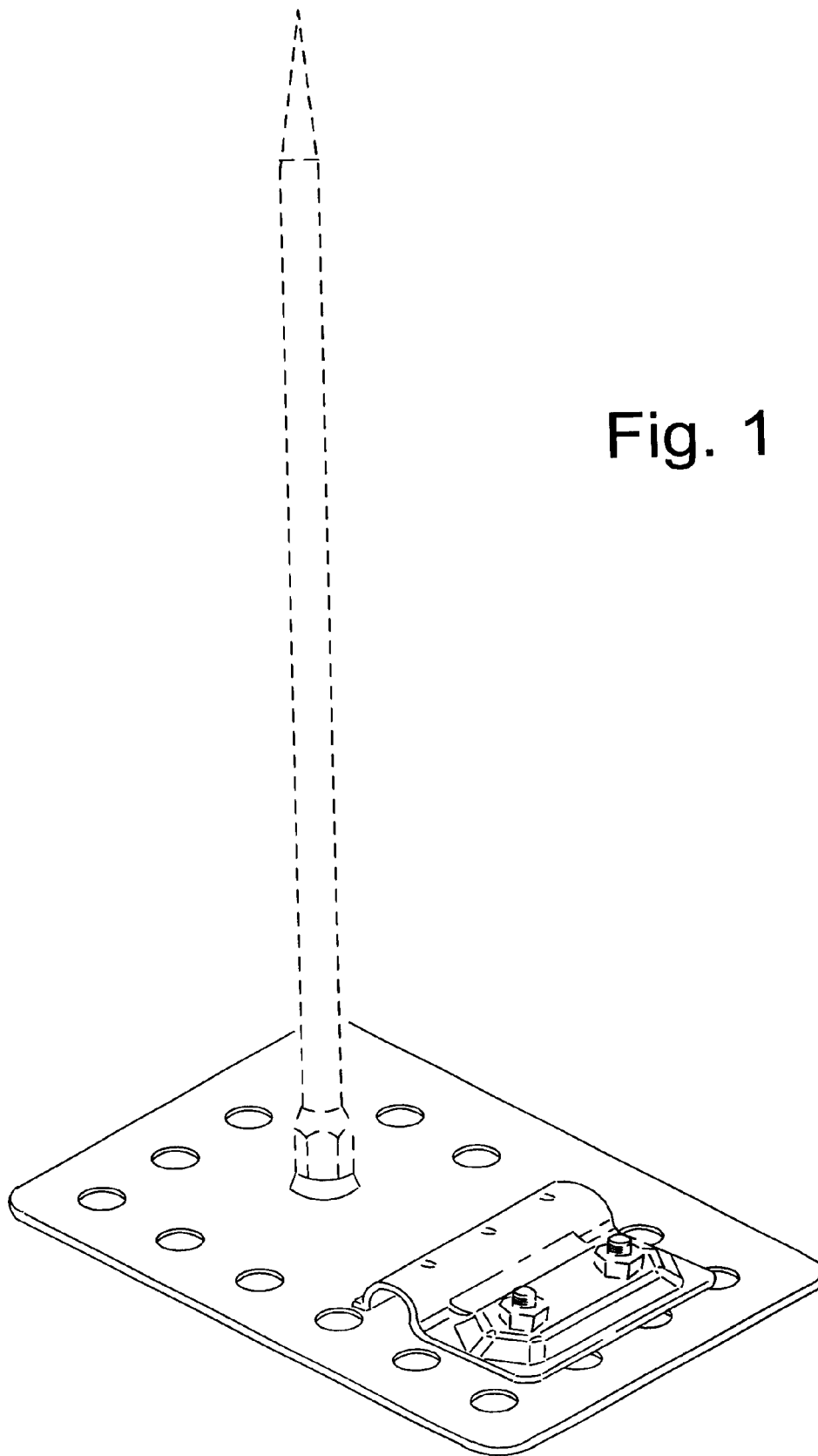
FIG. 2 is a left side elevational view of the present invention; FIG. 3 is a right side elevational view of the present invention;

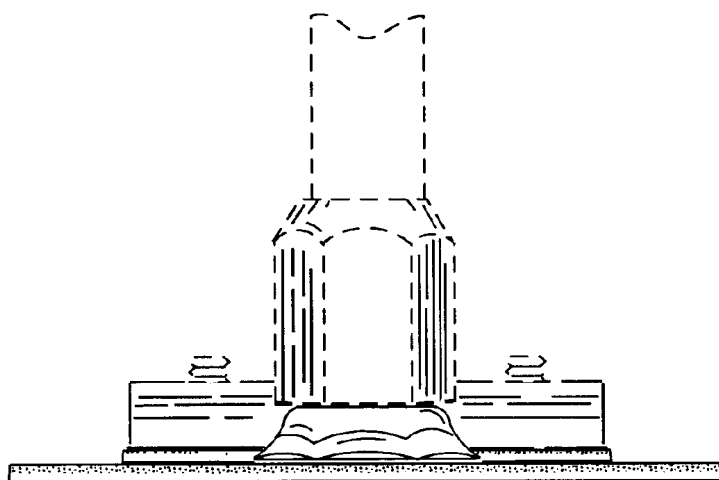

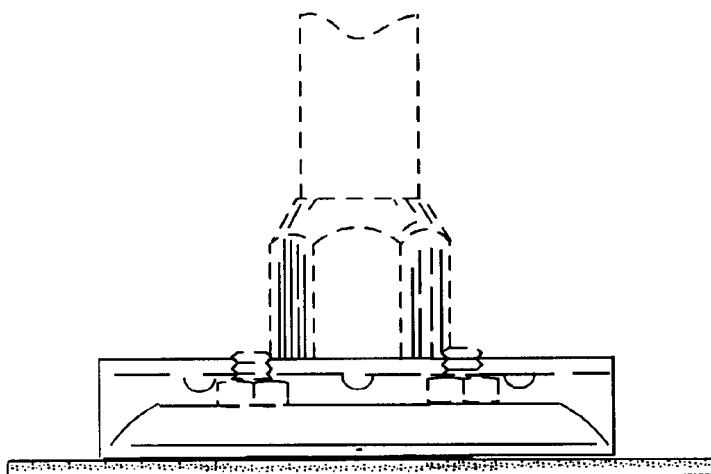

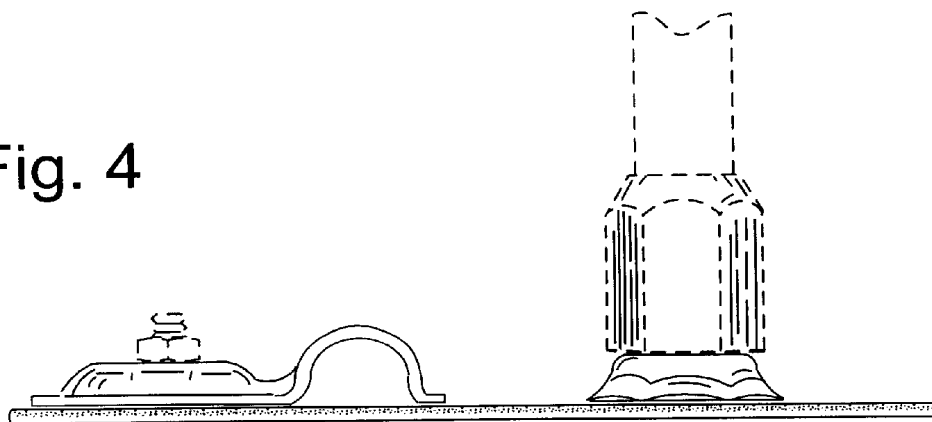

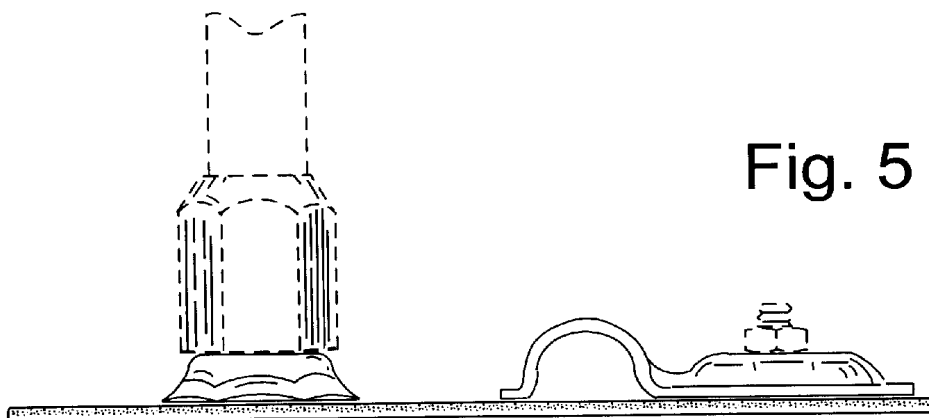

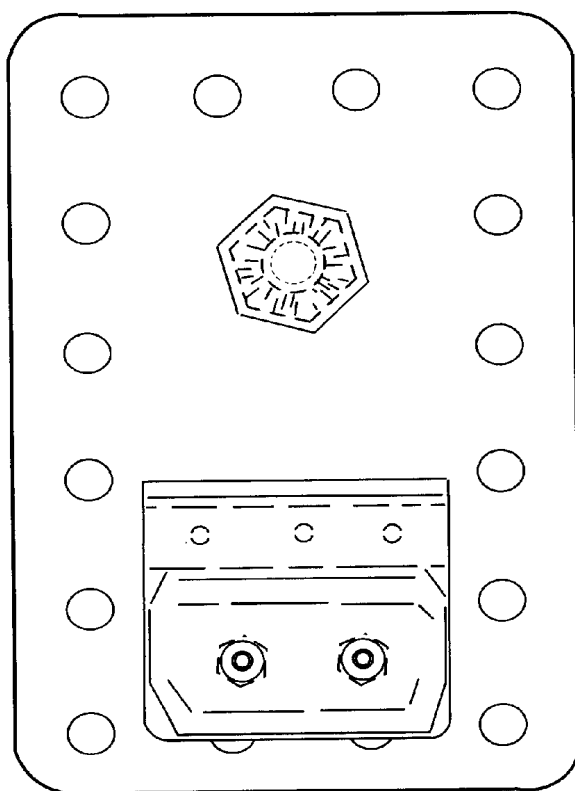
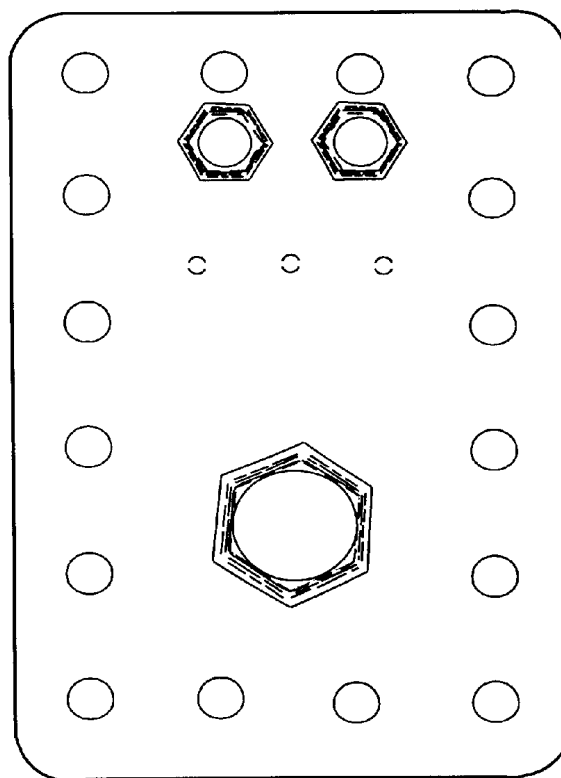
