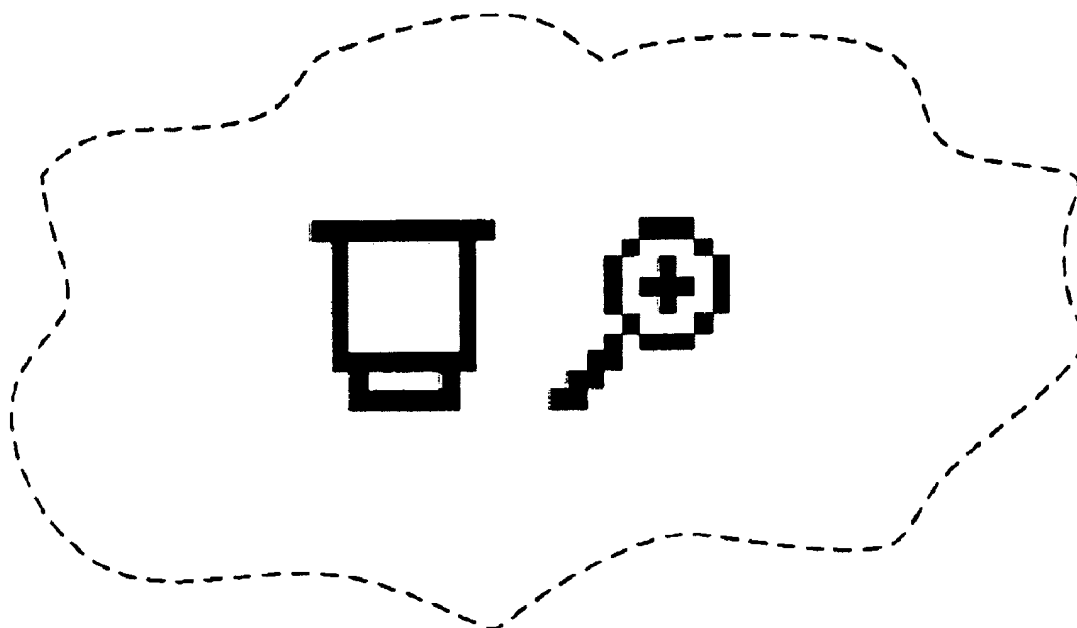
(57) **CLAIM**

The ornamental design for a computer icon for objective, enlargement, and contrast functions of a microscope system on a portion of a display panel or microscope display, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a microscope display with computer icon for objective, enlargement, and contrast functions of a microscope system on a portion of a display panel or microscope display showing our new design; and, FIG. 2 is a front view of a second embodiment thereof. The broken line drawing of a portion of a display panel or microscope display is for illustrative purposes only and forms no part of the claimed design.

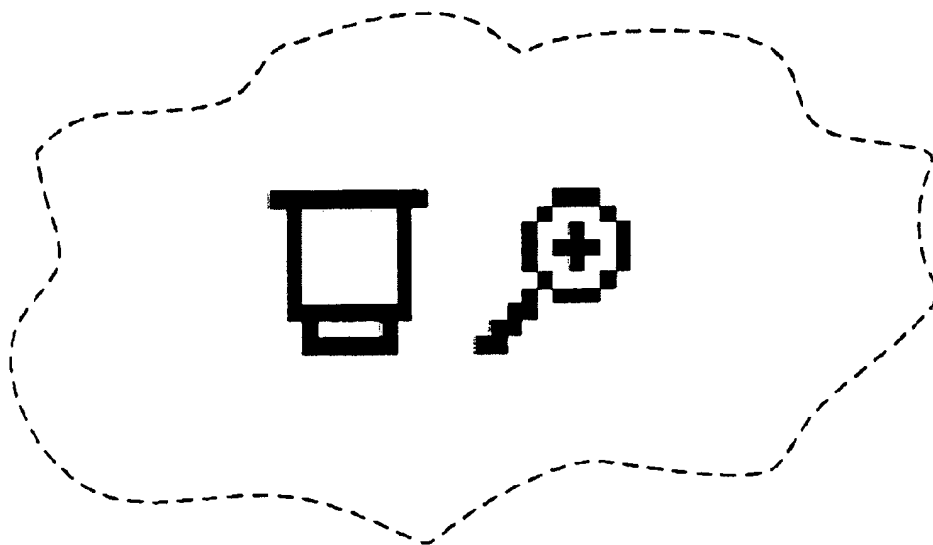

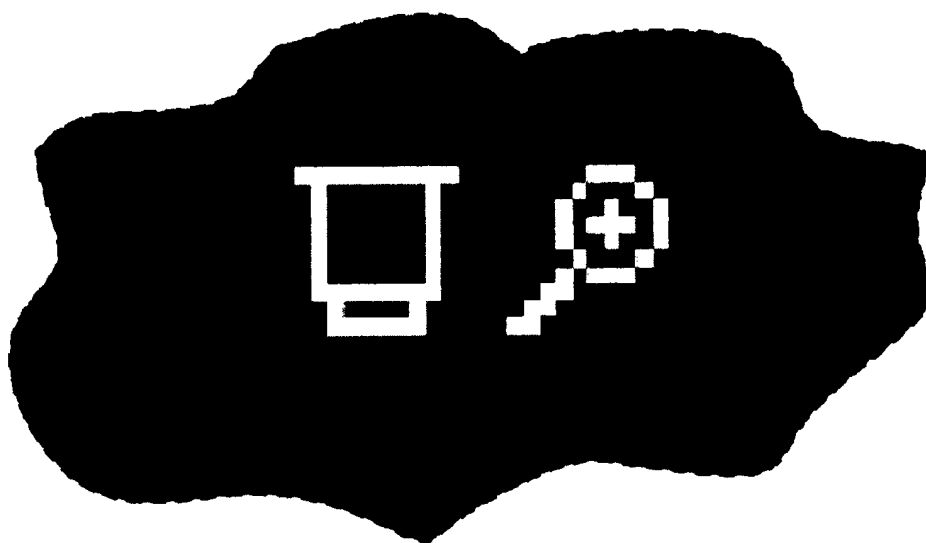
