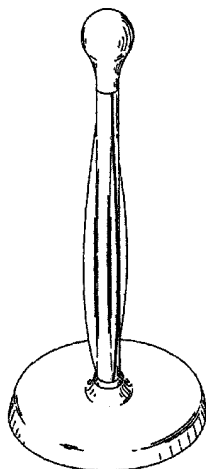
(57) **CLAIM**

The ornamental design for a rolled product dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present invention;
 FIG. 2 is a front elevational view of the present invention as shown in FIG. 1;
 FIG. 3 is a rear elevational view of the present invention as shown in FIG. 1;
 FIG. 4 is a right side elevational view of the present invention as shown in FIG. 1, with the left side of FIG. 1 being a mirror image of the right side;
 FIG. 5 is a top plan view of the present invention as shown in FIG. 1; and,
 FIG. 6 is a bottom plan view of the present invention as shown in FIG. 1.

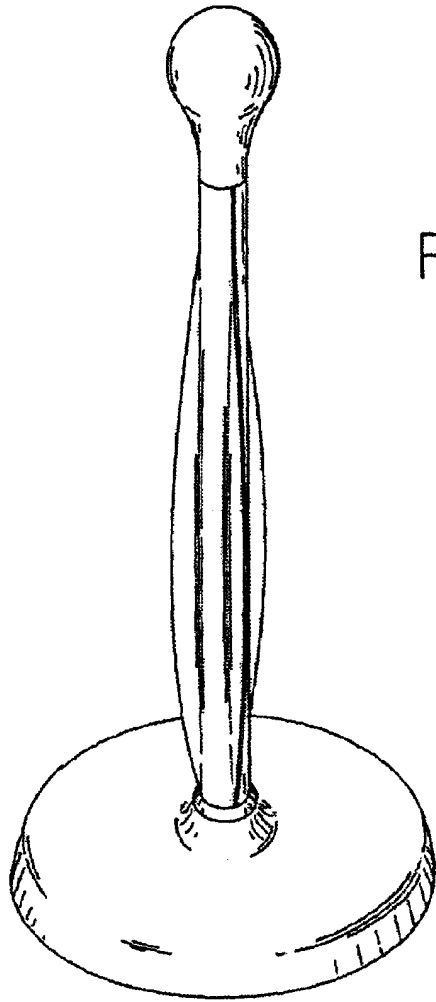

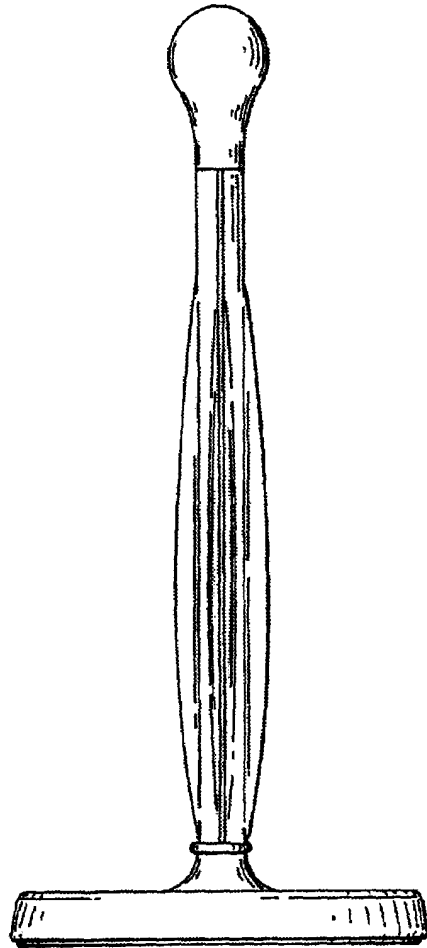

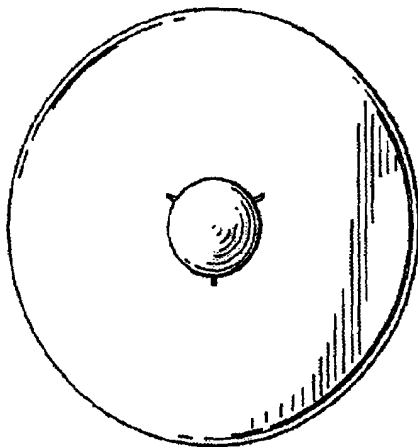

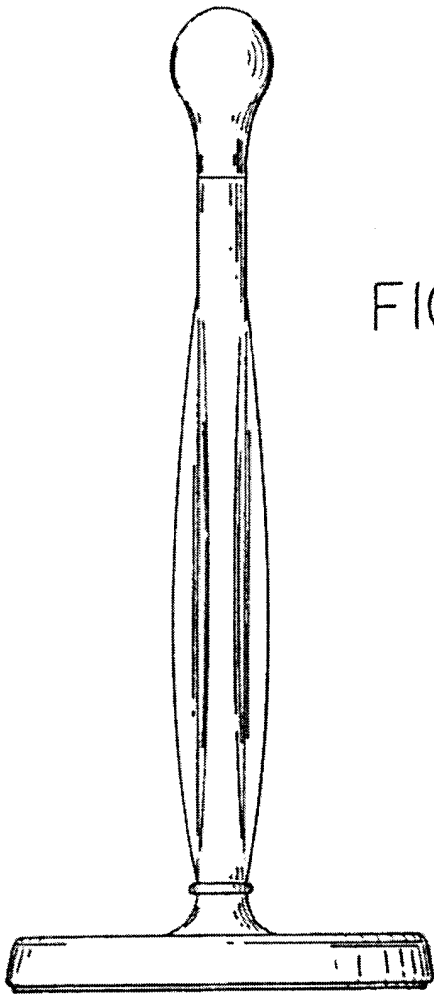

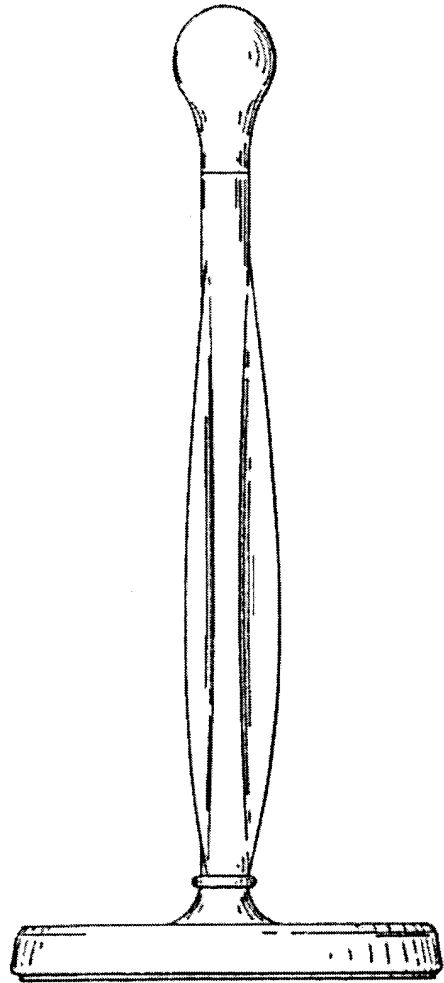

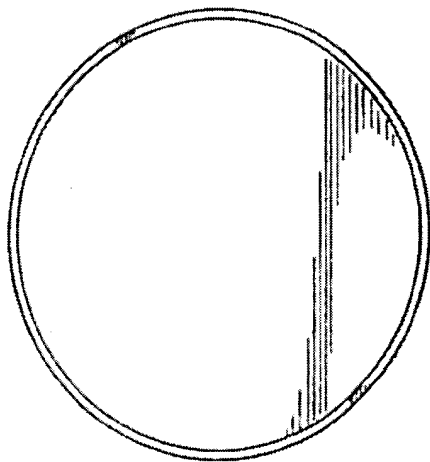
