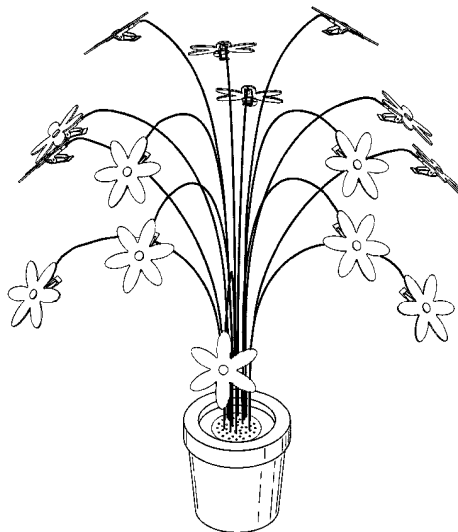
(57) **CLAIM**

The ornamental design for a floral photograph holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the floral photograph holder; FIG. 2 is a front elevational view of the floral photograph holder; FIG. 3 is a right elevational view of the floral photograph holder; FIG. 4 is a rear elevational view of the floral photograph holder; FIG. 5 is a left elevational view of the floral photograph holder; FIG. 6 is a top plan view of the floral photograph holder; and, FIG. 7 is a bottom plan view of the floral photograph holder.

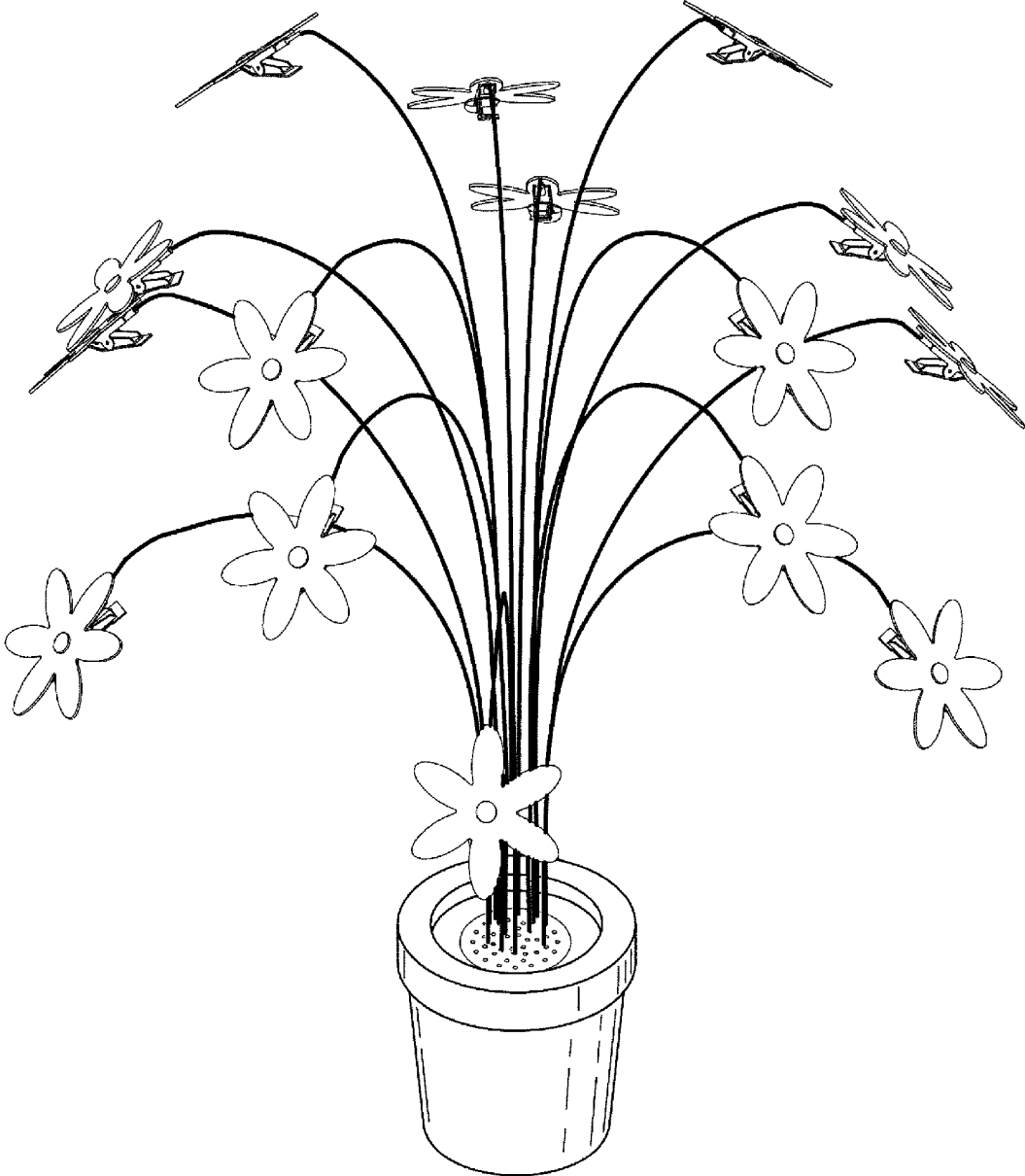

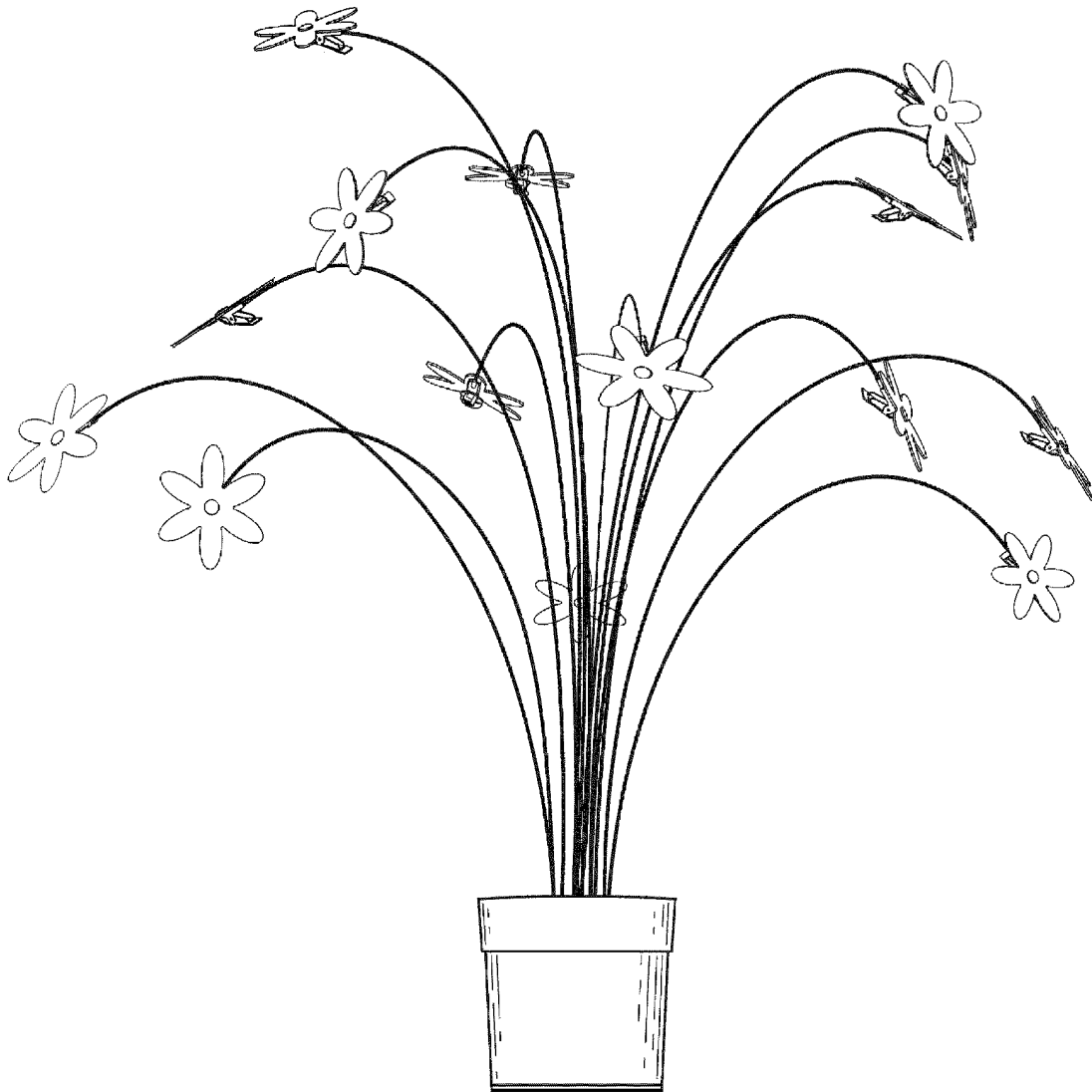

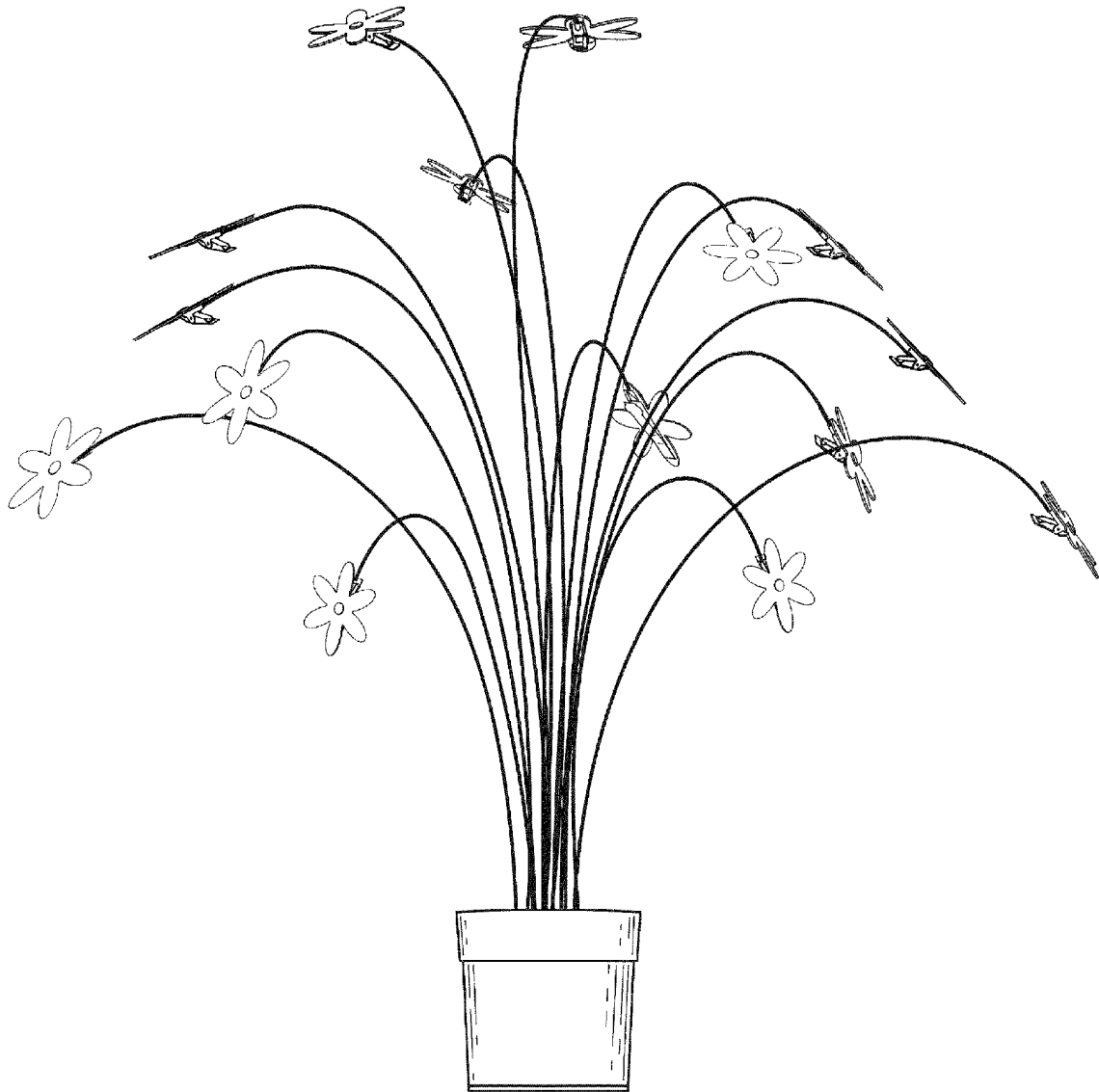

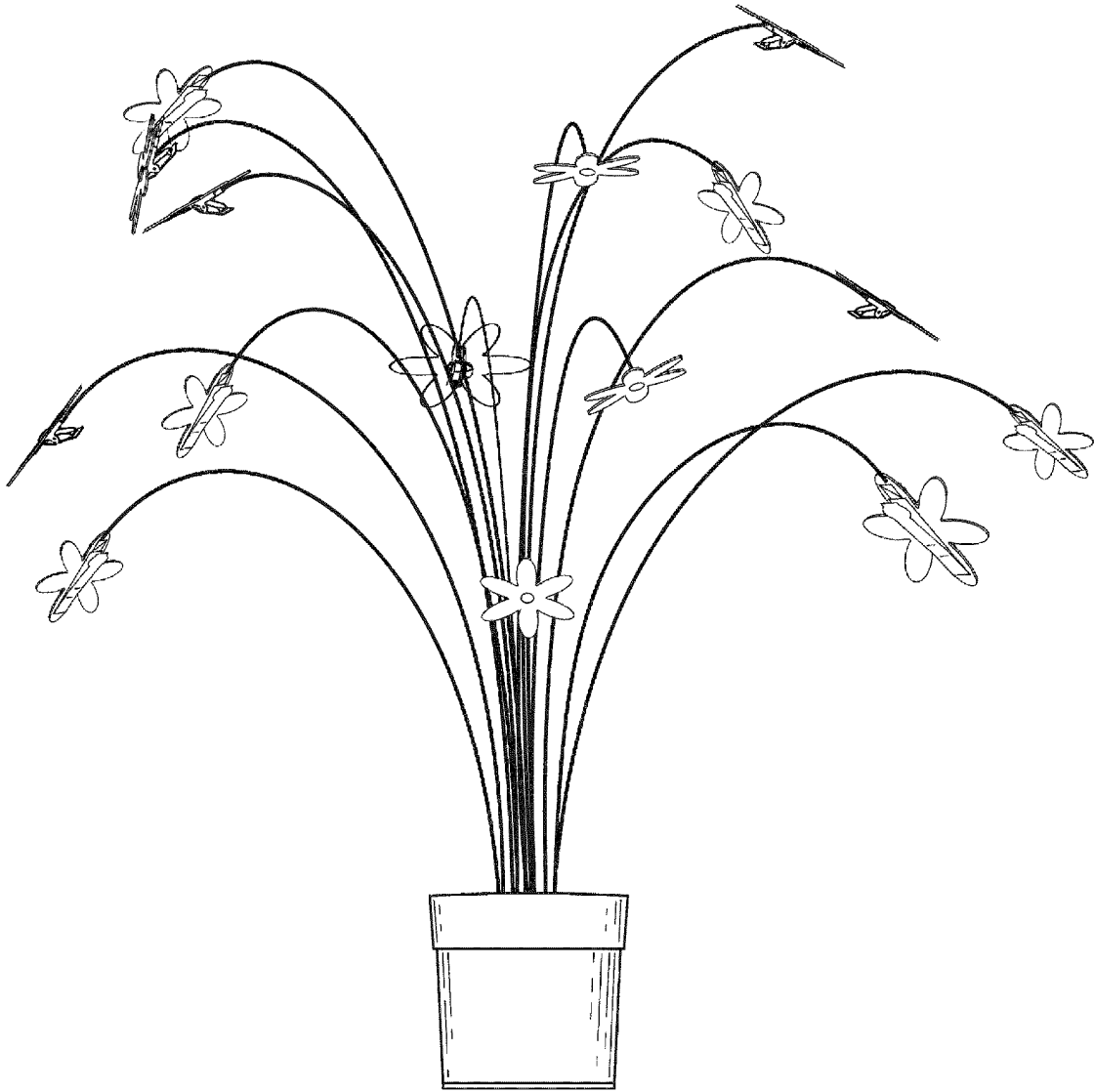

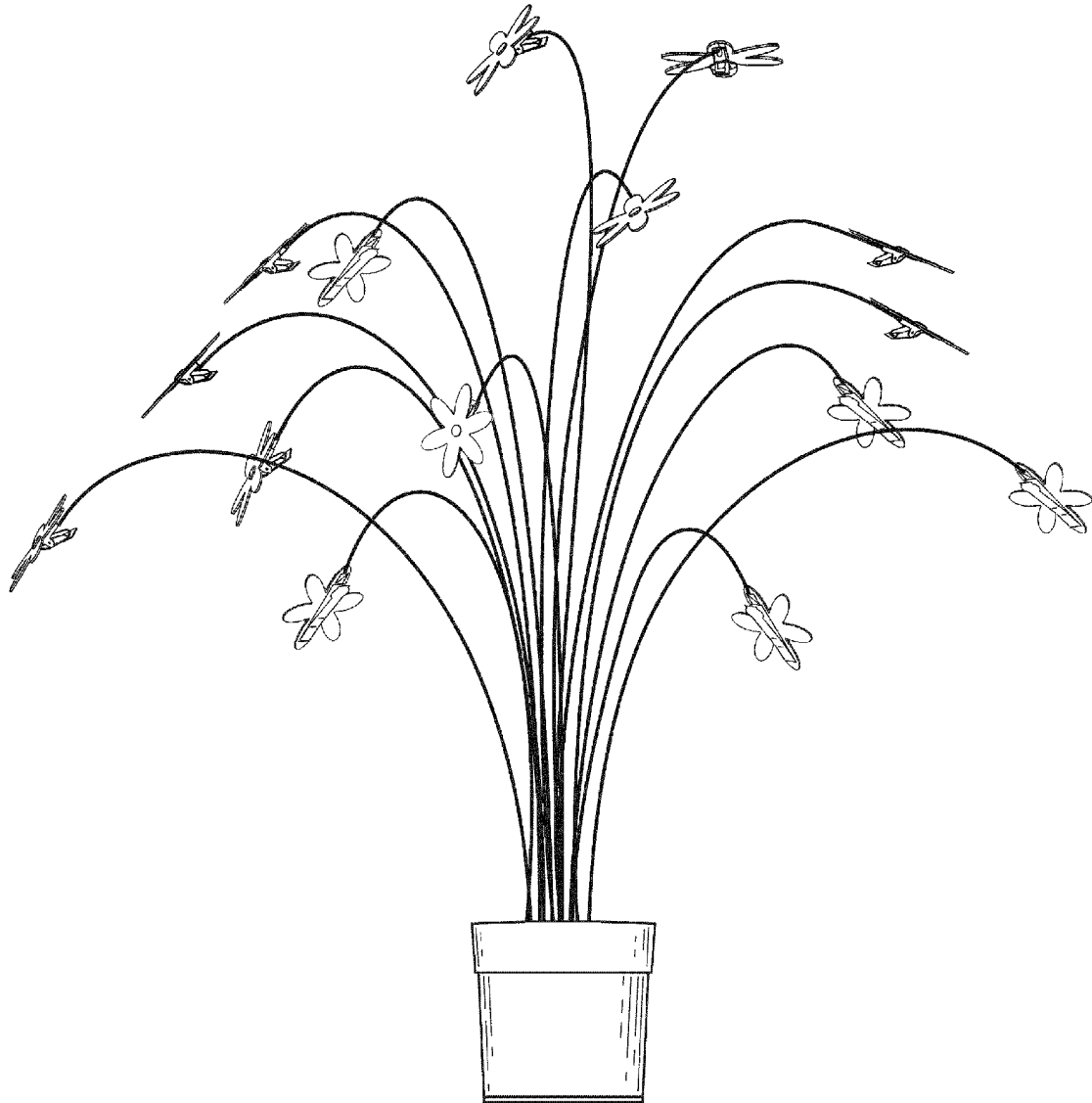

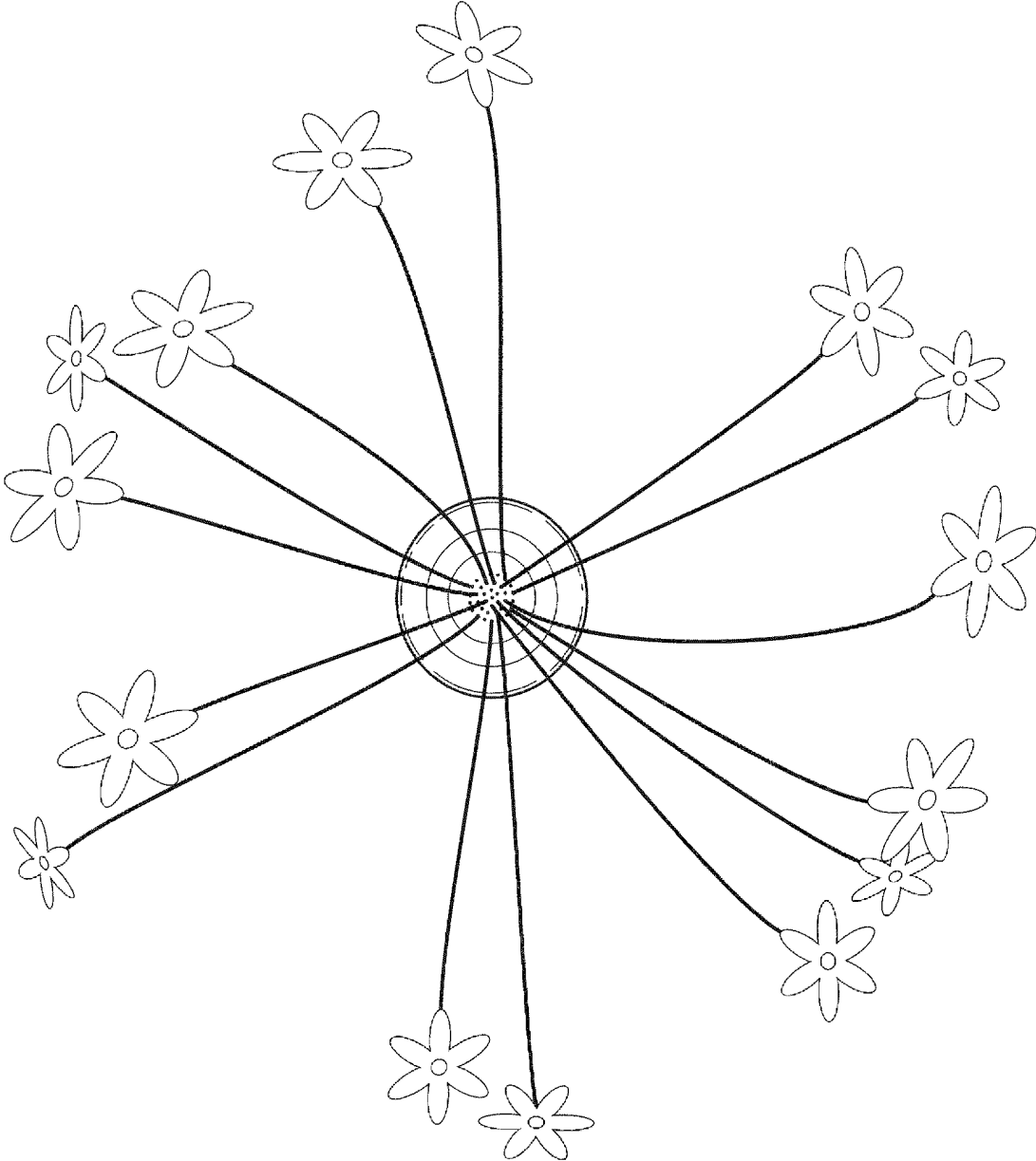

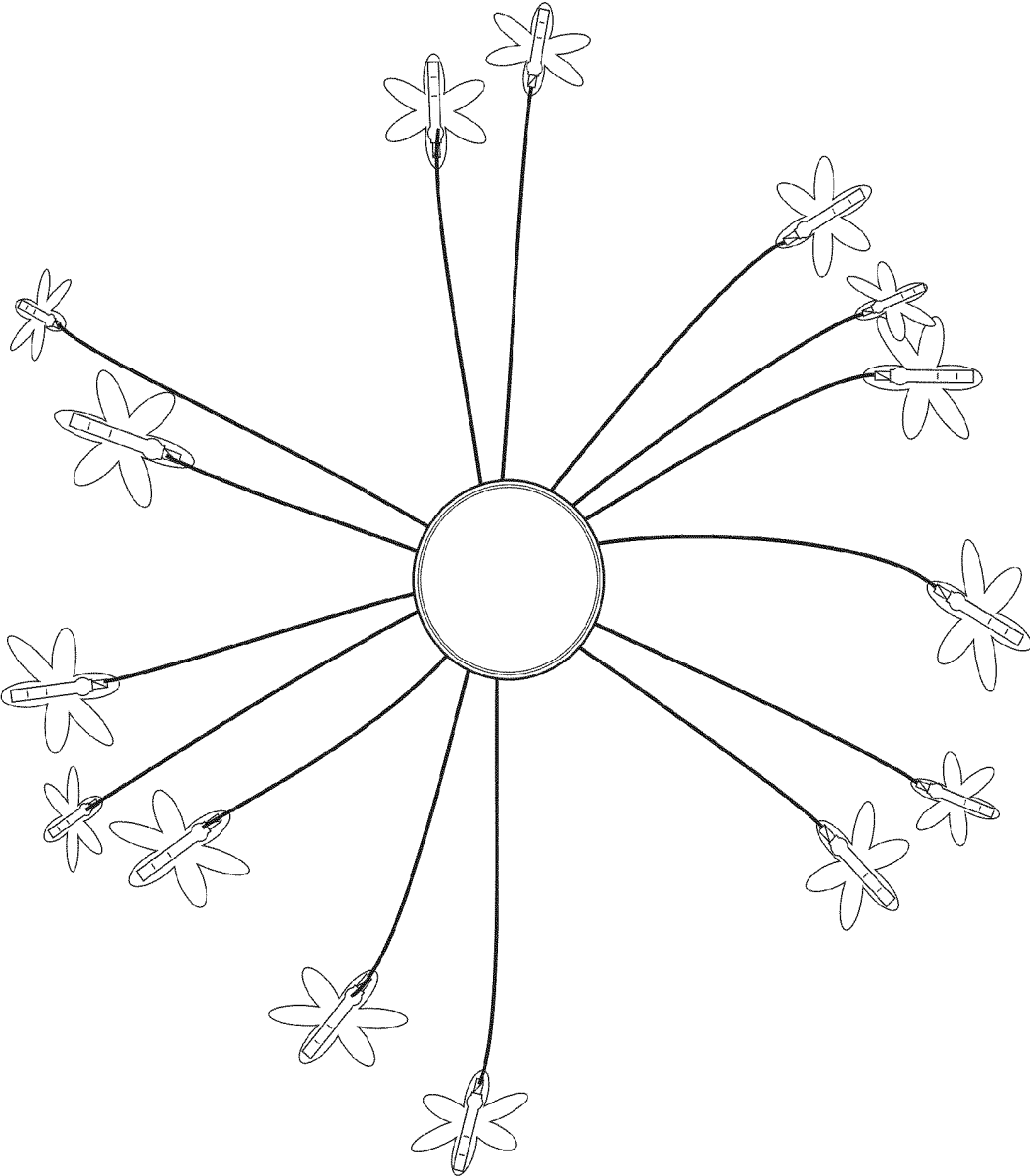
