**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a present invention electric ukulele;

FIG. 11 is a top plan view of the second embodiment of the electric ukulele;

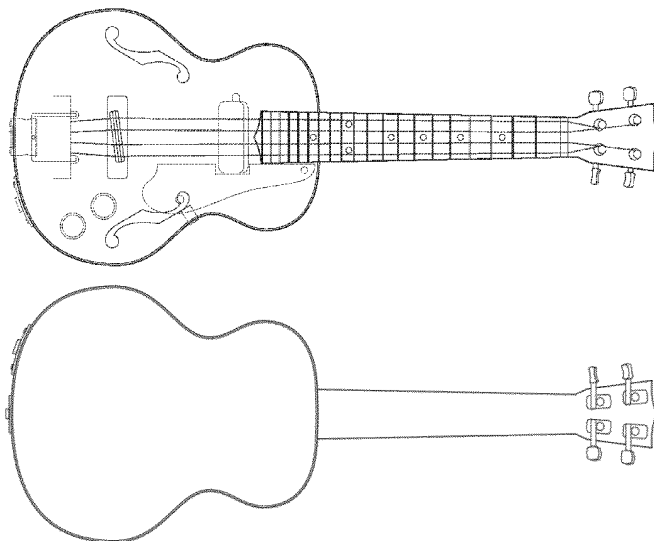
FIG. 12 is a bottom plan view of the second embodiment of the electric ukulele;

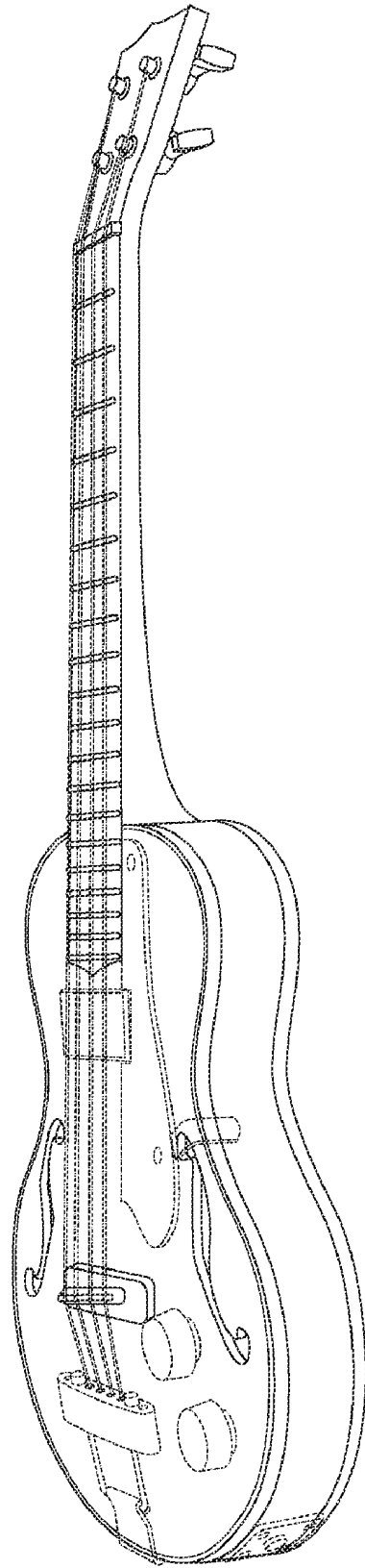

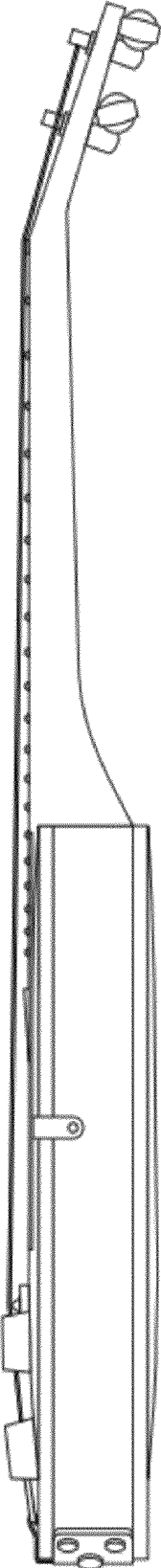

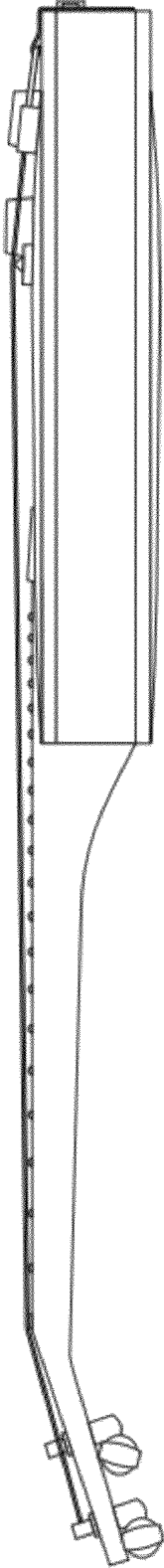

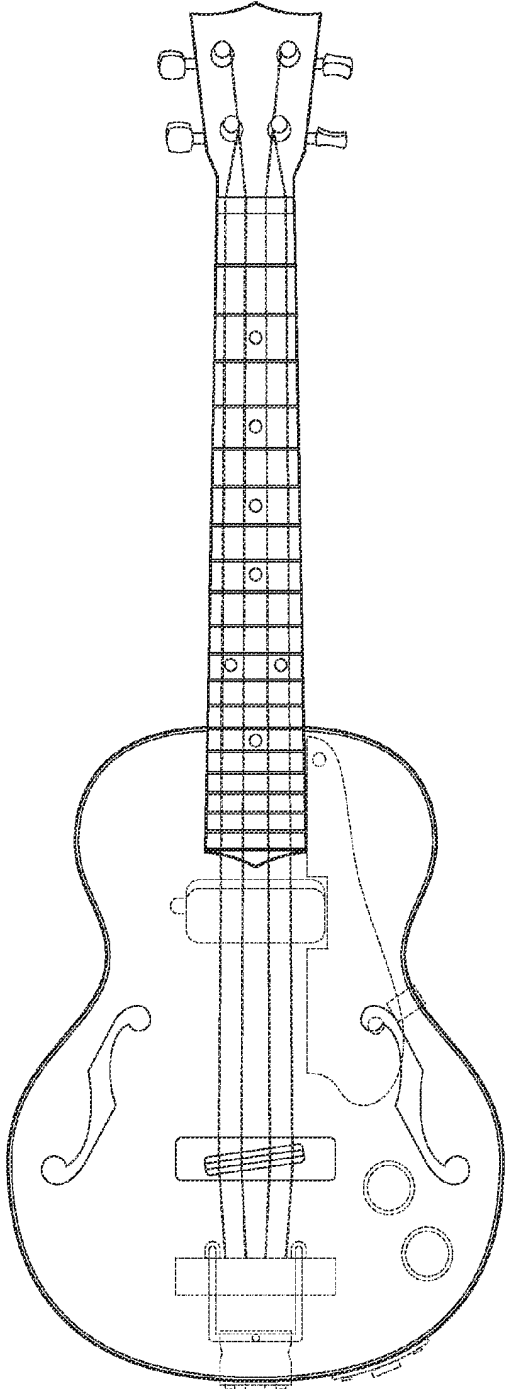

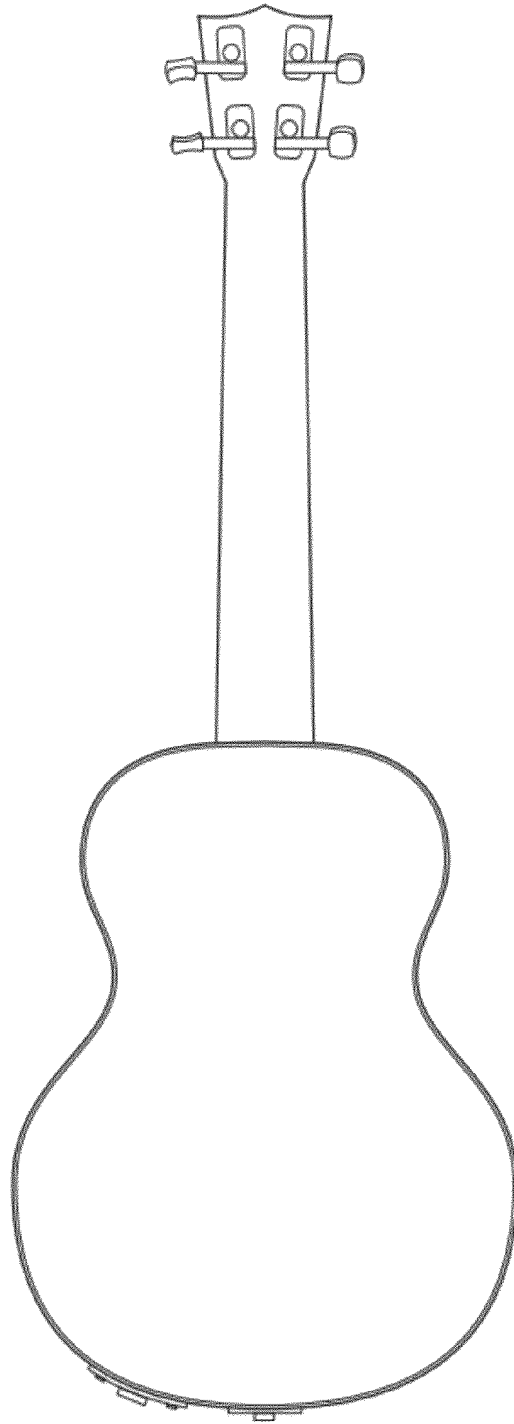

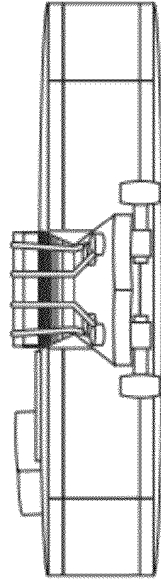

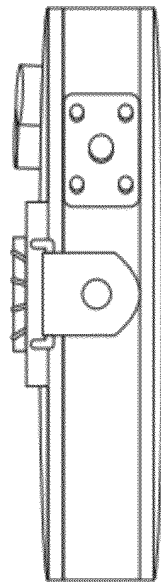

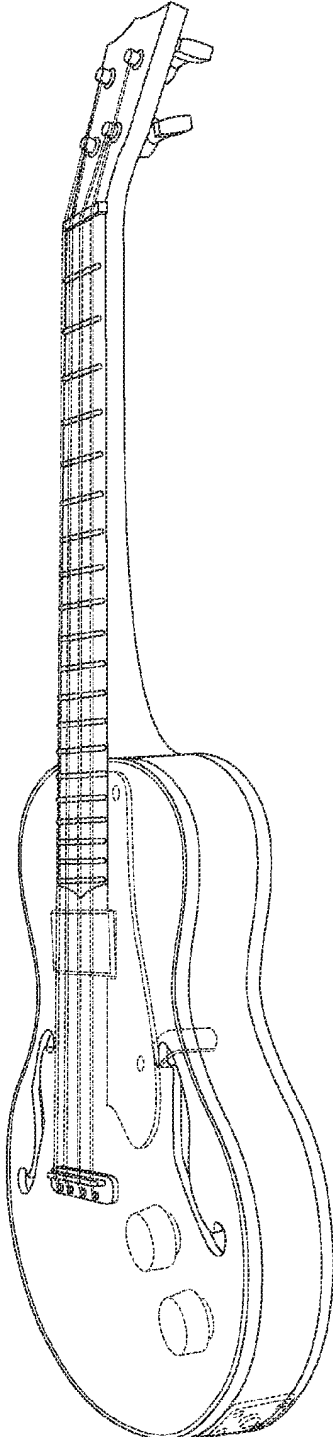

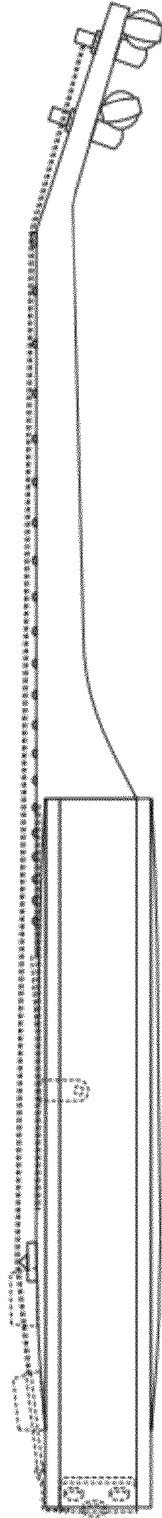

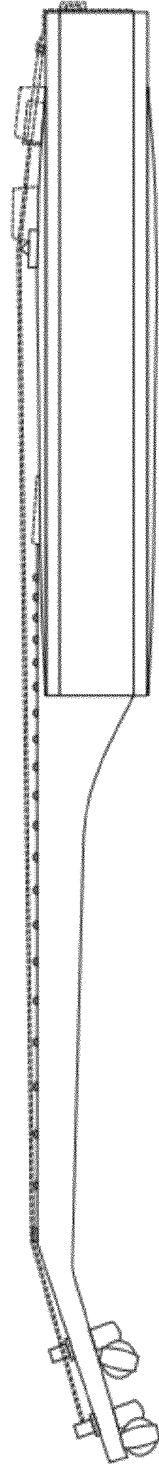

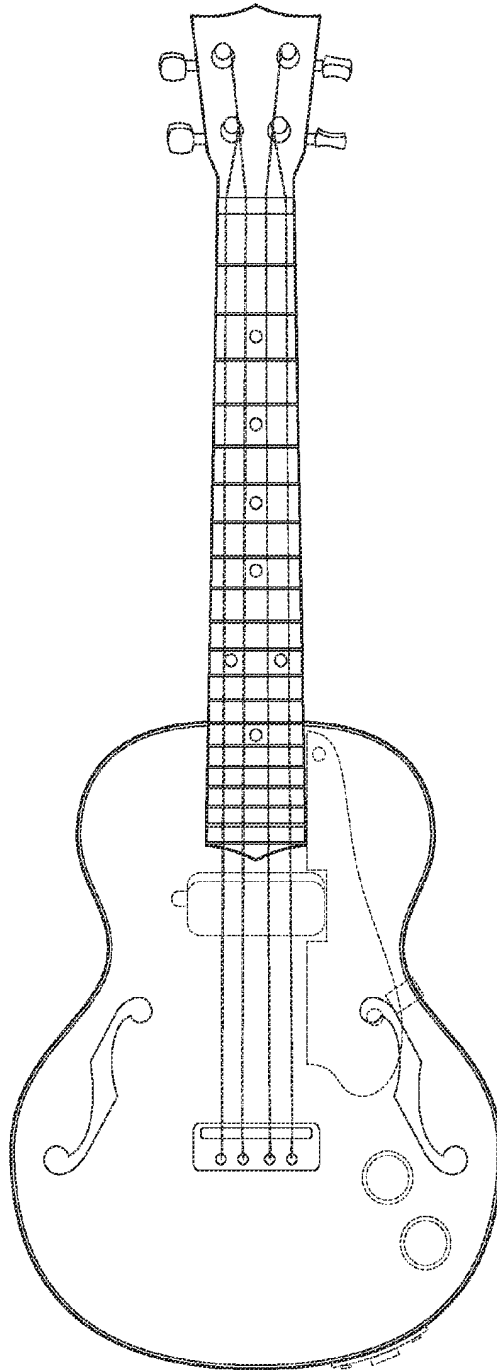

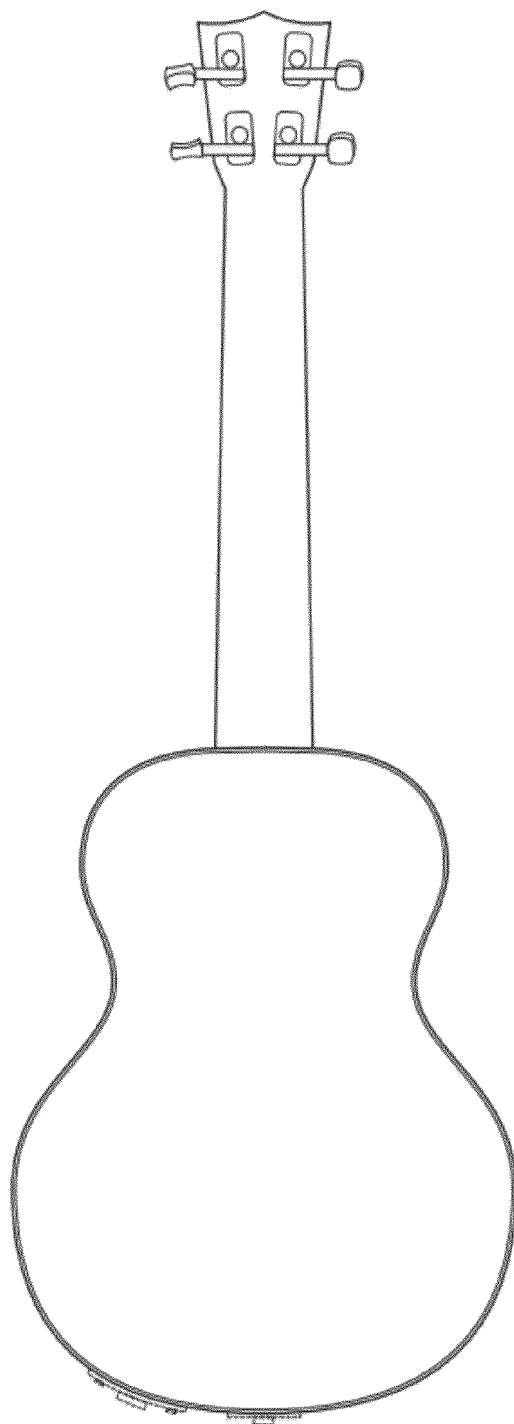

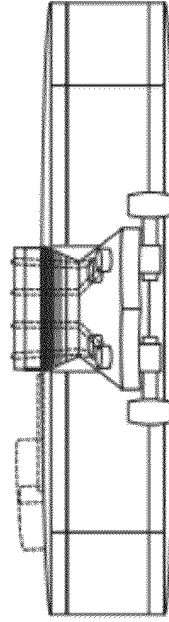

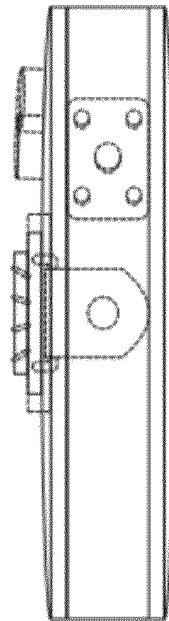
