FIG. 4 is a right side perspective view of the first embodiment;

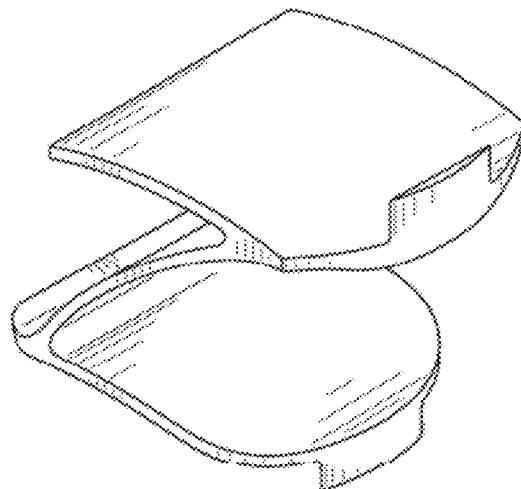
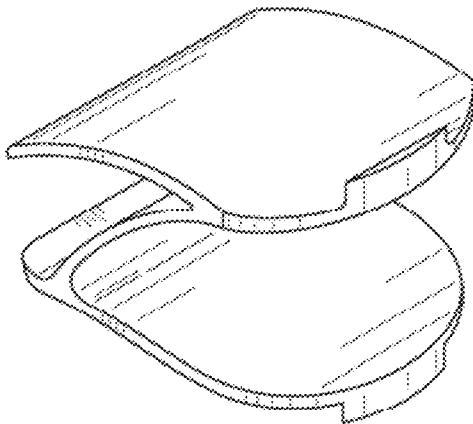
FIG. 5 is a right side elevational view of a second embodiment of the present invention;

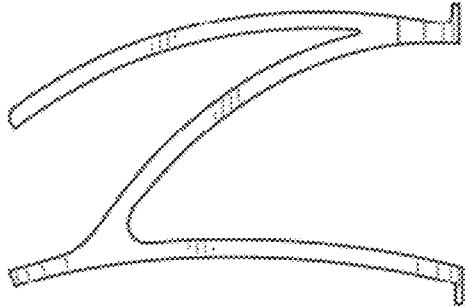

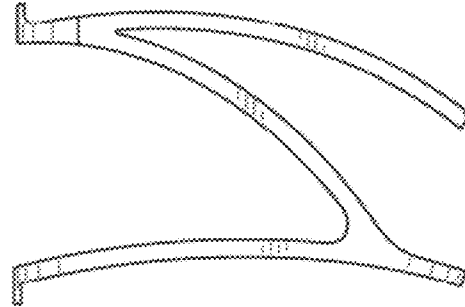

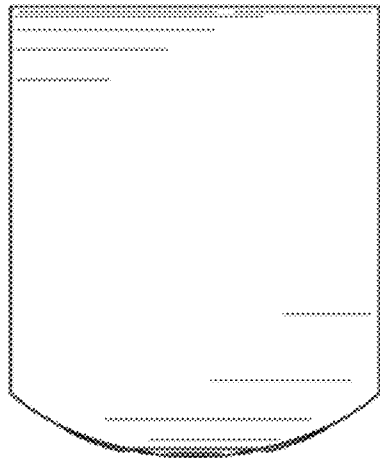

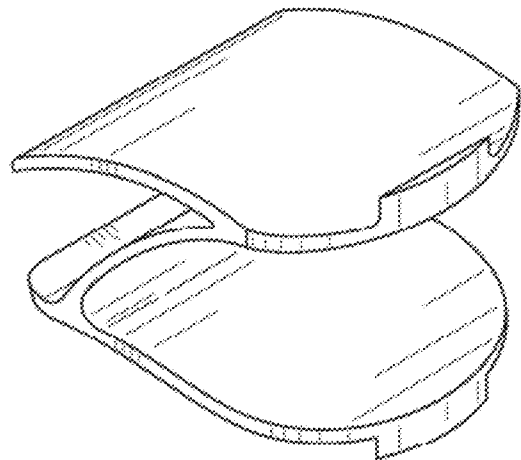

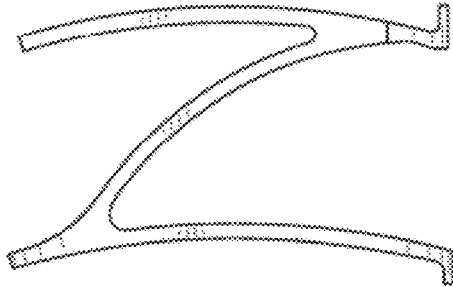

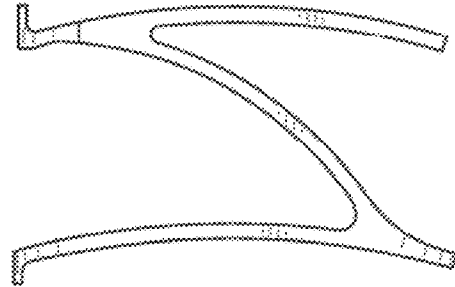

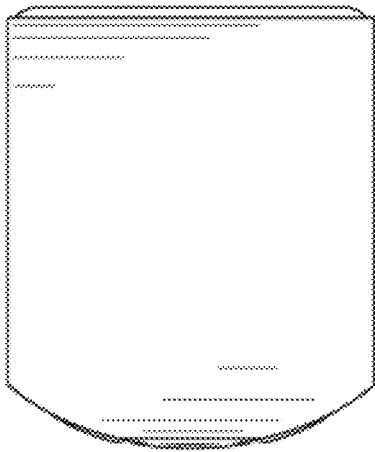

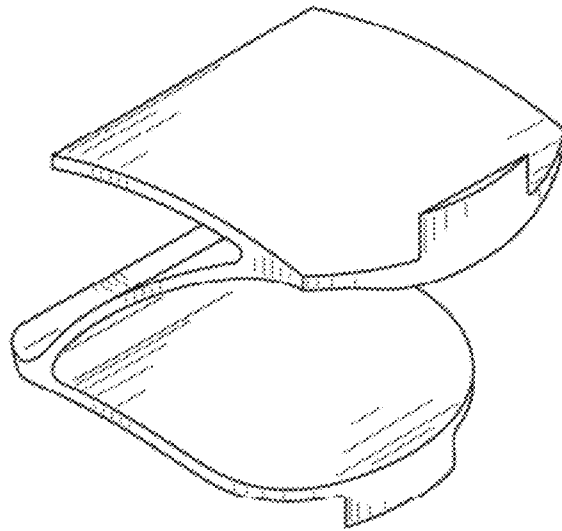
